We are pleased to announce that more than **\$55,000** for Enhancement Grants was recently awarded to **29** local Simi Valley public schools.

Our mission is to enrich and maximize the quality of education in the Simi Valley public schools by providing financial support for programs that assist in achieving academic excellence. 
29 Community Members Go Behind Bars... Jail & Bail Raises More than \$9,000
